## **CONTACT LIST REGARD CORRUPTION, CRIMINALITY, STATE ABUSE**

I appreciate there is a broad range of issues but the list is only long because everyone responsible for these issues, has failed. Although there is a considerable amount of information the outcomes sought can be broken down into four or five basic needs as

- 1.Return of my equipment illegally held for a year and a half
- 2. Normalise immigration and visa status,
- 3.Investigation into the corruption and criminality reported

(Inc Investigation into the abuse of the Home Affairs Dept and update from PSIRA regard their investigation)

- 4.Identify a person, with sufficient authority, to be able to lay criminal charges
- 5. Secure an attorney in regards to the various lawsuits

I have submitted a Letter of Good Cause to the Director General. I understand that the usual procedure is to first go to a local immigration office, to get permission to do so. However, as WDS and SAPS have proved themselves able and willing to interfere with my visa applications, visa extensions and immigration status at every opportunity and successfully so, i believe it would be counter productive to do so. Further, now that i have begun contacting or re contacting the organisations, bodies and persons responsible for investigating the corruption and criminality I am at considerable risk to further attempts at illegal incarceration and vulnerable to multiple other means to remove me from circulation. The chronology of the campaign have shown them more than willing to deploy any means they saw fit.

By having to widen the number of organisations and people I am contacting I am also adding considerable and unnecessary risk to the process. We had anticipated the reporting of the corruption and criminality would have resulted in an investigation which we hoped would have gathered considerable evidence before those accused were aware. Now due to the wider nature of the reporting of the corruption and criminality and the far less targeted approaches that is unlikely, providing time and warning both to destroy evidence and to make another attempt to remove me.

THE URGENCY: "I am trying to get everything sorted out as quickly as possible. My mother, who is in her late seventies, was diagnosed with lung cancer in 2022. Because of the sabotage of my visa extension by SAPS, Mr de Swardt and his clients. I have been unable to visit her. In fact, due to the Covid19 pandemic I have not seen her since leaving the UK in December 2020.

I am hopeful that the Letter of Good Cause to the Director General of Home Affairs, as well as my complaints to multiple relevant bodies, will result in the normalization of my immigration status. I would have been able to travel from the point the bogus immigration charge was withdrawn in September 2023. As such, the impossibility of extending my visa has resulted in the loss of almost a year when I could have spent precious and irreplaceable time with my mother."

As you can appreciate time is not on my side, and every day these issues remain unresolved is another day lost forever. I fear if this continues without resolution it will be too late".
